

THE SCHOLARSHIP

The Dafydd Lewis Trust provides equity and merit-based scholarships of \$10,000 a year, for three years, to young men who might not have otherwise received a university education due to the limited financial resources. Scholarships are awarded for full-time undergraduate degrees in most courses at any university in Victoria.

Established under the Dafydd Lewis Will in 1942, this scholarship is for young men completing Year 12. Young women can apply via the [Mary Jane Lewis Scholarship Foundation](#).

LEGAL ELIGIBILITY

Applicants must be studying a full-time undergraduate degree, at a tertiary institution in Victoria, in any course other than music, theology, education, or the arts.

- Applicants are permitted to undertake an arts course, but, must be enrolled with the purpose of gaining entry to a course which was previously offered by that institution as an undergraduate degree but is now only offered at the postgraduate level.

AUSTRALIAN CITIZENS

Applicants must have attended a Victorian Government Secondary School for at least five (5) consecutive years immediately preceding the award of the scholarship.

Applicants must be no more than 19 years old on the 1st of January 2027.

AUSTRALIAN VISA HOLDERS

Applicants who have entered or have remained in Australia under a Visa issued by the Commonwealth of Australia for any of the following grounds are eligible to apply:

- they, their parent or parents or any other person should be granted asylum in Australia; or
- they, their parent or parents or any other person were refugees; or
- any other humanitarian grounds.

Those eligible to apply holding a visa on the grounds of the above must:

- have attended a Victorian Government Secondary School for at least two (2) consecutive years immediately preceding the award of the scholarship; and
- be no more than 21 years old on the 1st of January 2027.

FINANCIAL ELIGIBILITY

To be eligible, applicants must be able to provide evidence of their parent/guardian receiving one or more of the below government allowances:

- Low Income Health Care Card;
- Centrelink Statement of Benefits; and/or
- Family Tax Benefit Statement.

Applicants who are their own legal guardian or have no active parent/guardian are to provide evidence of their own receipt of government allowance.

THE APPLICATION PROCESS & TIMELINE

Applications open: Tuesday 1st of September 2026

Applications close: Wednesday 23rd of December 2026 (11:59pm)

The Dafydd Lewis Trust assesses applicants via two stages:

1. Written application
2. Interview

Applicants will be notified if they are successful in the written application stage, in January of 2027.

Applicants successful in making it to the Interview stage will be invited to interview in January of 2027. Interviews are held at Equity Trustees offices and applicants are strongly encouraged to attend in person. Details regarding the exact time and date of interviews will be provided to successful applicants closer to the date.

This is a formal interview and should be treated as such. We recommend applicants treat this as they would a job application.

Applicants that make it to the interview stage will be notified to the outcome of their application no later than March 2027.

COMPLETING YOUR APPLICATION

REQUIRED DOCUMENTATION

All documentation should be uploaded in PDF format under the following naming convention:

The following legal documents are required to be submitted with your application:

- Birth Certificate (Australian or otherwise)
- Citizenship, Permanent Residency or Australian Commonwealth Visa (if applicable)
- VTAC ATAR Certificate
- Proof of Government Allowance
- A personal statement
- A personal referee statement

APPLICANT DETAILS

Applicants are required to upload accurate and up to date contact details. Contact details should be that of the applicant not of a parent/guardian or careers advisor.

Applicants are to upload a clear and legible copy of their birth certificate, citizenship, or permanent residency.

Applicants are to list all schools attended for the duration of their secondary education only, there is no need to list your primary school.

ATAR RESULTS

Applicants are to supply details of their ATAR and ATAR certificate. Please note we do not require a copy of your study score certificate, only your ATAR certificate/VTAC Results.

- Please note we do not accept screenshots of results, only certification as supplied by VTAC.

Applicants cannot submit their application until [December round offers](#) have been made on Wednesday 23rd of December 2026.

Applicants are to supply the details of the University Degree and Institution that they have been offered and accepted via an early offer or in the December offer round.

Applicants can be enrolled in any University Degree at the institution of their choice.

FINANCIAL ASSESSMENT

Applicants are only required to provide the contact & financial details of parent/guardians that directly care or provide for them. E.g. if you are estranged from a parent/s, you are not required to list their details or financials.

Applicants who are their own guardian, or, have no active parent/guardian are to provide evidence of their own receipt of government allowance.

FINANCIAL INFORMATION

If an applicant's parent/guardian receive any of the below government allowances, they are required to provide a copy:

- Low Income Health Care Card;
- Centrelink Statement of Benefits; and/or
